## **MEMBERSHIP TO AIDC LTD**

Any Australian resident with a personal or professional interest in documentaries may apply to the AIDC Ltd (AIDC) Board to become a Member. AIDC delegates registered for the upcoming conference who are Australian residents automatically become Members of AIDC.

Membership commences from the date of registration for the upcoming conference and expires on the day prior to the commencement date of the following conference. For example, if you registered for AIDC 2021 your membership expires the day before AIDC 2022 commences. AIDC 2022 will run as a hybrid event with in-person and online sessions from Sunday 6 to Wednesday 9 March, 2022, followed by an international online marketplace on Thursday 10 and Friday 11 March, 2022.
